

FAST Q TV Privacy Policy

Introduction

Fast Enterprises, LLC, and affiliated entities¹, ("Company" or "We") respect your privacy and are committed to protecting it through our compliance with this policy.

This policy describes the types of information we may collect from you or that you may provide when you use our applications or services, and our practices for collecting, using, maintaining, protecting, and disclosing that information.

This policy applies to information we collect through the FAST Q TV application.

It does not apply to information collected by:

- Us offline or through any other means, or
- Any third party (excluding our affiliated entities), including through any application or content (including advertising) that may link to or be accessible through our services.

Please read this policy carefully to understand our policies and practices regarding your information and how we will treat it. If you do not agree with our policies and practices, your choice is not to use our application or services. By accessing or using our application or services, you agree to this privacy policy. This policy may change from time to time (see <u>Changes to Our Privacy Policy</u>). Your continued use of our application or services after we make changes is deemed to be acceptance of those changes, so please check the policy periodically for updates.

Usage

The FAST Q TV application may only be used by licensees of the FAST Q software suite, and the application will only be distributed to those who are licensees.

Personal Data

We do not request, store, process, transmit, share, or sell any personal data such as email addresses, names, ages, or location data. We do not collect location information and do not track users. No information collected from our application is used to identify an individual.

Device and App Data

The Fast Q TV application requires an endpoint to function as a companion to the FAST Q software suite. The FAST Q TV application requests an endpoint URL during setup. The endpoint URL will be provided by

the licensee of the FAST Q software suite. All data sent to the FAST Q software suite during setup and use of the FAST Q TV application will be owned and may be retained by the licensee of the FAST Q software suite. This includes a record of API calls, push tokens and installed application versions. No other data from the device will be stored by us at any time.

All device and app data collected is used only for app functionality, personalization, and support.

We may collect and disclose aggregated information about our users (e.g. number of downloads, number of clients, etc.), or information that does not identify any individual, without restriction.
